**TRUSTEE’S NOTICE OF DESTRUCTION OF PATIENT RECORDS MAINTAINED BY  
SADLER CLINIC PLLC AND MONTGOMERY COUNTY MANAGEMENT COMPANY, LLC**

On June 15, 2012 (the “*Petition Date*”), Sadler Clinic PLLC and Montgomery County Management Company, LLC (collectively, the “Debtors”) filed their voluntary petitions for relief under chapter 11 of title 11 of the United States Code (the “*Bankruptcy Code*”). The bankruptcy cases were converted to cases under chapter 7 of the Bankruptcy Code on August 2, 2012. Allison Byman (the “Trustee”) was subsequently appointed the chapter 7 trustee of the Debtors’ bankruptcy estates.

On August 23, 2012, the Bankruptcy Court entered an order authorizing a process by which the custodian(s) of the medical records, maintaining the medical records through and including August 23, 2014, shall destroy all physical and electronic medical records, relating to the patients of Sadler Clinic PLLC and Montgomery County Management Company, LLC. [See Docket No. 253 in the above referenced Bankruptcy case].

**PLEASE BE ADVISED THAT AS SOON AS AUGUST 24, 2014, THE MEDICAL RECORDS OF SADLER CLINIC PLLC AND MONTGOMERY COUNTY MANAGEMENT COMPANY, LLC, IN BOTH PHYSICAL AND ELECTRONIC FORMAT, COULD BE DESTROYED.** Any requests you have for these records should be made well in advance of that deadline and said request should be directed to the custodian of records.
